Re:	Academic Calendar Temporary Delegation of Authority

Issue

In response to the Coronavirus crisis, the College will need to adjust the academic calendar to balance the health and safety of students, faculty and staff, with the continuation of its primary medical mission. Academic Calendar decisions are the purview of the Board of Regents. The Administration requests a temporary delegation of authority to adjust the academic calendar through August 31, 2021, at which point the authority would revert back to the Board of Regents. The President would notify the Board of any such adjustments.

<u>Overview</u>

This initiative will allow the College to be nimble enough to respond timely as the crisis evolves.

Recommendation

Staff recommends that the Board of Regents grant temporary delegation of authority to the President to adjust the academic calendar through August 31, 2021, at which point the authority will revert back to the Board of Regents.
