## I. INTRODUCTION

A. Call to Order

A Regular Meeting of the Northern New Mexico Branch Community College was held on March 31, 2020, in the Board Room of Northern New Mexico College, Espanola Campus. Board Members present: Gilbert Serrano (in person), Board President, Moises Peña (Via Zoom), Marvyn Jaramillo (Via Zoom), Antonette Serrano (Via Zoom) and Donald Valdez (Via Zoom). Vice President Jon Paul Romero was not available to attend the meeting.

Northern New Mexico College Staff Present: Richard J. Bailey, Jr., PhD, President, Ivan Lopez Hurtado, PhD, Provost & Vice President for Academic Affairs; Ricky A. Bejarano, CPA, CGMA, Vice President – Finance & Administration; Vince Lithgow, Comptroller; Evette Abeyta, Budget Director and Amy Pena, Executive Assistant to the President, Board Secretary.

Others in attendance: Jo Boderra, Rio Grande Sun, John Ussery

The meeting was called to order at 5:33pm by Board President Gilbert Serrano. Board Member Antonette Serrano took roll call for those in attendance at the meeting. Espanola – present, Pojoaque – not present, Jemez – present, Mesa Vista – Present, Chama Valley – present.

## II. APPROVAL OF AGENDA

President Serrano entertained a motion for approval of the Agenda.

Board Member Antonette Serrano moved to approve the Agenda. Second – Board Member Peña. A roll call vote was taken Roll Call Vote: Espanola – yes, Jemez Mountain – yes, Mesa Vista – yes, Chama Valley – yes. Motion passed unanimously.

### **III. APPROVAL OF MINUTES**

Board President Serrano asked if there are any questions regarding the minutes. Board President Serrano entertained a motion to approve.

Board Member Peña moved to approve the Minutes of July 2 and Minutes of July 11. Second – Board Member Valdez. A roll call vote was taken. Espanola – yes, Jemez Mountain – offline, Mesa Vista – yes, Chama Valley – yes. Motion passed unanimously

## IV. APPROVAL OF FY 21 BUDGET

President Bailey stated the budget starts on page 11 which includes the projected revenue and expense and statements along with salary report. President Bailey stated when the Board was formed and these meetings happened in July it was to come together and put the ballot together for election. The Mill Levy passed by almost 63% of the Board. President Bailey thanked the Board for being leaders in the community to make this happen. There is roughly a \$2.4M annual budget for consideration. If approved this will be folded into the overall College budget which will then go to the Board of Regents next month and then submitted to HED by May 15th. Embedded are the salaries for professors, salaries, etc. to get this off the ground. President Bailey asked if the Board had any questions

Board Member Valdez asked how many professors there would be. President Bailey stated a Chair for the Trades, a Full Time Faculty for Plumbing & Pipefitting and a Full Time Faculty for Electricians and four part time professors. President Bailey stated this is being opened up to Junior, Seniors in Hight Schools and Community Members. There is going to be a transportation network from all the high schools. Board Member Valdez asked if within the budget if there is any type of contingency if there is an overabundance of people interested. Is it sufficient to utilize the FTEs for the classes? President Bailey stated what will happen is because you cannot have one faculty member and so many students, there is a limit of how many can be in the class. We hope we have that problem. If there is an abundance, we will use the tuition revenue to cover this. What makes this challenging is in 2008 a lot of people ended up going back to school. Even though we are dealing with the health crisis we know there is an economic crisis going on with it. Right now, in New Mexico we have a double whammy, a month ago Russia and Saudi Arabia were struggling in terms of oil production, that led to oil prices dropping dramatically and because of the virus a bottom fell out of the service industry. The service industry will not look the same and a lot of those people may be looking at a different career path. This is complicated but there are many different factors that may lead to a lot of people looking at a different path.

President Bailey asked Ricky Bejarano, Vice President – Finance & Administration if he had anything to add. Mr. Bejarano stated this covers it. The latest estimates is it will be between a \$1B and 2B shortfall. Board Member Gilbert Serrano asked who the instructors were going to be. President Bailey stated the College offered it to the 412 and 611 and in an ideal world we would like to hire their adjuncts. They may not want to hire the full-time faculty. The MOU does not speak to hiring a full-time faculty members. What may happen is we have graduates from our own plumbing and electrician programs who might want to take these positions. Dr. Lopez stated the MOU is to hire the individuals as adjuncts in the training centers. He is asking the unions to help us identify people we can hire. We sent the advertisement to the unions and are asking them to help us to recruit. It does not mean we will hire one of them. Whoever is the best candidate are the ones we will hire. Board Member Valdez stated he is hoping we can get skilled workers from the construction industry. President Bailey stated he went to Albuquerque and sat with the Carpenters Union. They are looking to replicate this with the carpenters. We want to be sure when we have the third program we want to be ready to roll.

Board President Gilbert Serrano entertained a motion to approve the budget as presented. Board Member Valdez moved to approve. Second – Moises Pena. A roll call vote was taken Espanola – yes, Jemez Mountain – yes, Mesa Vista – yes, Chama Valley – yes. Motion passed unanimously.

Board Member Jaramillo stated he is excited to see how this is going to go. President Bailey stated it is the leadership of the Board that made this possible. It is our community that stepped up. He is super excited. We are going to get the plumbers lab and electrician lab up to speed. When we get through this we are going to invite all the Board Members to get through a ribbon cutting to celebrate this with all the Board.

President Bailey stated he has some sad news. Jon Paul just sent a text he is dealing with a very sick father but he sends his best to everyone. Please keep his family in your prayers.

#### V. ADJOURN

Board President Gilbert Serrano entertained a motion to adjourn.

Board Member Valdez Moved to adjourn. Second Moises Peña. A roll call vote was taken. Española – yes, Jemez Mountain – yes, Mesa Vista – yes, Chama Valley – yes. Motion passed unanimously.

A Special Meeting of the Northern New Mexico Branch Community College was held on November 5, 2020, in the Board Room of Northern New Mexico College, Espanola Campus. Board Members present: Gilbert Serrano, Donald Valdez, Antonette Serrano, and Jon Paul Romero. Board Members not present: Moises Peña. Board President Serrano called roll for the meeting: President Serrano – president, Vice President – Jon Paul Romero, present via phone call, Secretary – Antonette Serrano – present via phone call, Member Moises Peña – not present, Member Donald Valdez – present. Board President Serrano stated the Board has a quorum and can conduct business.

## I. CALL TO ORDER

Board President Serrano called the meeting to order at 3:06PM.

President Bailey stated Board President Serrano would like to start the meeting with the Pledge of Allegiance. President Bailey stated there are no formal decisions so the meeting could begin.

Board President Serrano turned the meeting over to President Bailey.

Board Member Valdez asked if anyone had the Robert's Rules of Order handy, he thinks a quorum is required in any type of meeting. He does not think decision process is part of it but the quorum is detrimental to the procession of the meeting. Board President Serrano stated he thinks we can have an informational meeting without a quorum, that is what he presumes. It is just going to be informational. Board Member Valdez stated he would leave it up to Board President Serrano. Board President Serrano stated if it is informational, he thinks it is alright. Antonette Serrano joined the meeting and there was a quorum of the Board.

Board President Serrano stated there is a quorum and Board business can be conducted. Board President Serrano again handed over the meeting to President Bailey.

## II. APPROVAL OF AGENDA

President Bailey thanked everyone for attending the meeting. President Bailey stated we do not have a quorum but we can go through the agenda without anything formal. Board President Serrano stated as long as we do not have anything to vote on, it is good. President Bailey stated everything is informational.

#### III. BUDGET UPDATE

President Bailey started the meeting with a discussion of the budget and turned it over to the Vice President for Finance & Administration Ricky Bejarano and he will introduce Evette Abeyta who is the budget guru and expert on all things. Mr. Bejarano stated Evette has developed this specifically for the Community College just by way of introducing this format and it can be changed however the Board needs. The relevant columns other than the descriptions to the left are the last 6 columns which show the original budget, any adjustments that the College makes and the final budget. Then we have year to date which is not going to be as extensive as usual because we just started July 1st as far as getting the budget. Encumbrances is money not spent yet but essentially is a commitment to spend that money and then the available budget. Ms. Abeyta will explain the carryover from last year, the \$1.9M and what has come in so far. Mr. Bejarano introduced Ms. Abeyta who actually does this work. Ms. Abeyta stated basically at the top of the worksheet you will see the total revenue year to date. She hardcoded in the prior year revenue at the \$1.9M and that is really, she still needs to book this in Banner but she wanted to give the Board a glimpse of what is actually been received from last fiscal year. The \$35,588 is actually current year Mill Levy receipt. Total Mill Levy through today \$1.9,993 and some change. Basically, we are going to project that we will receive the additional Mill Levy that will probably come through early next year and they bill now in November or December and payments come through in January or May. We will be seeing more revenue coming in. Basically, we will adjust the budget to stay within the actual revenue so we don't overspend it. If you go to total expenses, you will see what we have been allocating to the different departments as we are creating them. The full budget was originally in the administration budget in the operation budget and so slowly you will see on the second column for that administration budget is we have started shifting the money to other areas. One of them being the maintenance and operations. You will see we have actually expended \$6,000 there and then we have committed in encumbrances about \$48,612. If you go to the next page, you will see where we transferred some money into the technical trades area. Again, this is part of covering the salary for the technical trades staff and then we have expended year to date \$49,423 and we have \$2,491 encumbered. Just to give the Board a feel, with this, we do not encumber salaries. It is not in the reserve but in the budget. The next one, which is new, something we just created is Career Services and maybe Dr. Lopez would want to touch base on what that is exactly. We then have the Registrar piece where we budgeted a percentage of the support, we receive from the current Registrar for the Branch Community College. It is just a small percentage. You will see the Business Office Support and we have one accountant being paid from the Branch Community College. Again, this is just support from the Business Office. The last item is the BR&R and you will notice there is no budget in there right now but there are some reserved encumbrances of \$38,000 in there and the reason there is no budget appropriated to that yet is because HED will require us to do a transfer from the original budget into BR&R. That is just their way of reporting. At the very bottom, total expenses year to date you will see the \$63,476 and the committed encumbrances are at \$93,850. Ms. Abeyta asked the Board if they had any questions.

Mr. Bejarano stated regarding revenues, obviously the second half of taxes are due in December so that money begins to roll in about February and that is when we expect the other \$1M to catch up to bring us to the \$2.9M in total revenue from the Mill Levy. The \$1.9M is what was in the bank from last year so far and a little more trickled in \$35,000 but there should be another \$1M coming in to bring us to the \$2.9M total. We have a lot of maintenance coming, a lot of getting the dorms up. We are installing the fire alarm system but that will be coming, \$100,000 will be coming from the Bond allocation we received.

Mr. Bejarano asked if there were any questions. There were no questions from the Board. Vice President Romero thanked President Bailey for the presentation. Board President Serrano thanked the staff for the informative presentation on the finances, he is sure it was a lot of work and thank you for all the work. Board Member Serrano asked if the slides will be sent for those of the Board Members who participated via phone along with President Bailey's PowerPoint. President Bailey stated they would be sent along with the spreadsheet.

#### IV. OPERATIONAL UPDATE

President Bailey stated regarding operations, he wanted the Board to hear from him regarding COVID response. The challenge for the team was to make sure when we are on the other side of the pandemic and we can start these hands on classes and so that the community is not waiting for us. As board members in the respective districts, you have made very thoughtful decisions in terms of the health and safety your communities, we are doing the same thing at the College. We have 95% of out curriculum online. The only exceptions that we have made right now are the nursing skills labs because you cannot teach someone to put an IV on online. There are one or two science labs with minimal students and we are mitigating the risk as much as possible. We are going to operate the same way in the spring with a couple of exceptions. The ones we just talked about and we have our Provost and Vice President for Academic Affairs, Dr. Ivan Lopez with us who can answer some specific questions. We are going to have several courses in the spring that will be in an eight-week term. The ones that start in January, likely, we will not be in a safe enough position to have them in person. We have a second eight-week term and if we have a vaccine, if it is widely available, if we have a community with an opportunity to take it and have enough people to take it then those classes, if students and faculty agree, we will do it and it includes the hands-on classes in El Rito. We know those are going to need to be in person. If it is safe to do so, we will start that term late depending on the availability of the vaccine. We do have key players at the meeting, Dr. Frank Loera, Chair of the Trades, Steven Skelton, Professor in Plumbing, John Ussery, Director of Grant for ECMC Foundation and serving as El Rito Director. Mr. Ussery's job is to get the facilities ready so the work can be done. President Bailey asked everyone for a quick introduction. Dr. Loera stated he is the chairperson of NNMC Branch Community College Technical Trades Department. He thanked everyone for letting him work at the Branch Community College and on these programs. John Ussery stated he has been in El Rito since 1976 and when he arrived, they are trying to pay attention to designing all the changes to make it healthy and COVID compliant as well as functional. Stephen Skelton stated he is the plumbing and electrical instructor for the Branch Community College. He thanked the Board and the tax payers of Rio Arriba County to share his knowledge with student's. He is very proud of the multicultural diversity of the students in Northern New Mexico. He is looking forward to sharing ideas and life experiences and guiding them down the path to a well-paying job. They will cover all aspects of plumbing and electrical work. How to communicate with clients, low flow plumbing, residential heating boiler installation and work with the New Mexico Plumbing and Mechanical Union to train the students so they will enter the workforce with well-paying jobs. He wanted to say the El Rito campus is a beautiful and

valuable resource and he is proud to be part of the revitalization of the instruction of plumbing and electrical trades. President Bailey stated we are grateful to have these three professionals on the team. President Bailey stated also present is Michael Martin, Board President and thanked him for being present at the meeting. President Bailey asked if there were any questions and gave a virtual tour of the work that the team has been doing on getting the campus ready. We have given an offer to and received an acceptance for our new instructor in electricians. We will introduce that professor soon. President Bailey gave a special thank you to Mateo Frazier who provided the aerial shot of the El Rito Campus.

## V. TOUR OF EL RITO CAMPUS

President Bailey gave a special thank you to Mateo Frazier and students who provided the aerial shot of the El Rito Campus and presented it to the Board. This is part of the drone program at the College. President Bailey asked if there were any questions. Board President Serrano asked if there were questions.

### VI. ADJOURN

Board President Serrano entertained a motion to adjourn.

## Board Vice President Romero moved to adjourn. Second – Board President Serrano. Motion passed unanimously.
