





High School Equivalency Program (HEP)	66 students	The High School Equivalency Program (HEP) helps migrant and seasonal farmworkers (or children of such workers) who are 16 years of age or older and not currently enrolled in school to obtain the equivalent of a high school diploma and, subsequently, to gain or upgrade employment, begin postsecondary education or training, or enlist in the military. Out of 66, 53 earned a High School Equivalency diploma (i.e. 80% awarded). Of the 53 who earned a High School Equivalency diploma, 48 students or 91% enrolled in postsecondary education, training programs and/or gained/upgraded employment











Student Class Distribution







* There was a sharp decline in the number of GED students enrolled in the fall 2020 term in comparison with previous fall terms. The reason is COVID-19 related. The majority of GED students who enrolled as FTAC students were transitioned from our GED programs. Both HEP and AE programs saw drastic reductions in participants. In addition, many attainees who could have enrolled in the fall 2020 semester did not want to pursue post-secondary education online.
