ARP/HEERF III Report Quarter Ending December 31, 2021

Financial Report

On March 11, 2021, The U.S. Department of Education announced additional funding will be available to higher education institutions to ensure learning continues for students during the pandemic. Northern New Mexico College (NNMC) was notified and received funds for Emergency Financial Aid Grants to Students under Section 18002(a)(1) of ARP.

NNMC received \$1,716,877.00 from the Department of Education to provide Emergency Financial Aid Grants to students under ARP (HEERF III). As of this report, NNMC has distributed \$1,716,877.00, 100% of the Emergency Financial Aid Grants directly to students.

NNMC divided the HEERF III funds into two disbursements, the first disbursement eligibility was based on a student being degree seeking and registered for classes at the end of the Spring 2021 semester. The second disbursement eligibility was based on a student being degree seeking and registered for classes as of the census date (September 3, 2021) of the Fall 2022 semester. Amounts each student received was based on their Expected Family Contribution (EFC) and credit load.

The total number of students receive the first disbursement was 838. As of the time of this report the number of students who received the second disbursement was 878.

No application was necessary for students to receive the distribution of Emergency Financial Aid Grants under HEERF III. To award the funds NNMC will review at all eligible student's credit load and EFC. Awards amounts for the first disbursement ranged from \$625 to \$1,150. Award amounts for the second disbursement ranged from \$310 to \$1,147.

The amount each student receives will be based on course load and the Expected Family Contribution (EFC) from the Free Application for Federal Student Aid (FAFSA).

Q: When will I receive my HEERF III funds?

A: Student who are receiving HEERF III funds and have direct deposit in place will receive their funds the week of October 25, 2021. If you do not have direct deposit in place a check will be mailed to the current address on file with Northern, the week of November 1, 2021.

Q: Why wouldn't I receive a HEERF III funds?

A: Students who are Non-Degree attending less than half time and Dual Credit students will not receive HEERF III funds.

Q: Will HEERF II funds be Applied to Outstanding Balances on my Student Account?

A: No, these grants will not be applied to outstanding balances on student accounts. Any balance on your student account will still need to be paid in full.

The amount each student receives will be based on course load and the Expected Family Contribution (EFC) from the Free Application for Federal Student Aid (FAFSA).

Q: When will I receive my HEERF III funds?

A: Student who are receiving HEERF II funds and have direct deposit in place will receive their funds by August 27, 2021. If you do not have direct deposit in place a check will be mailed to the current address on file with Northern, on September 3, 2021.

Q: Why wouldn't I receive a HEERF III funds?

A: Students who are Non-Degree attending less than half time and Dual Credit students will not receive HEERF III funds.

Q: Will HEERF II funds be Applied to Outstanding Balances on my Student Account?

A: Yes, IF the student replied to the institution by the August 10, 2021 deadline giving NNMC permission to have the funds applied to their accounts. All other students, the funds will not be applied to outstanding balances on their student accounts. Any balance on your student account will still need to be paid in full.
